## 1 – TOPIC

Disability-Inclusive Development: International donors' strategies and approaches on the inclusion of persons with disability in development cooperation.

## 2 – TARGET AUDIENCES

The webinar cycle is addressed to the three target groups of the project, namely:

1. Development practitioners (for instance: agencies, EU delegations)
2. National institutions of the partner countries of Bridging the Gap II (Burkina Faso, Ecuador, Ethiopia, Paraguay and Sudan)
3. National organisations of persons with disabilities

This session is particularly addressed to development practitioners belonging to international agencies and EU delegations.

## 3 – SESSION'S CONTENT, SEQUENCE AND DURATION

According to the United Nations, "Disability-inclusive development means that all stages of development processes are inclusive of and accessible to persons with disabilities"<sup>1</sup>. It requires that all persons be afforded equal access to education, health care services, work and employment, and social protection, among others.

Attitudinal and environmental barriers to participation have profound social, economic and cultural effects on persons with disabilities, resulting in exclusion and creating often insurmountable obstacles in relation to health services, education and employment.

This session explores the links between disability and development and the role of international cooperation in promoting approaches to the inclusion of persons with disabilities.

### What is this session about?

- Reviewing the provisions on disability-inclusive development and international cooperation detailed in the Convention on the Rights of Persons with Disabilities (CRPD);
- Providing suggestions for practical strategies for ensuring that all aspects of national and international development efforts are inclusive of persons with disabilities;
- Presenting examples on how different forms of international cooperation can support the implementation of the CRPD in developing countries, via:
  - Cooperation with States
  - Cooperation with International Organizations
  - Cooperation with International and Regional NGOs and DPOs
  - South-south cooperation, Triangular Cooperation, Decentralised Cooperation
- Recommending proposals for mainstreaming disability in development and cooperation.
