# **Overview & Objective**

Under the theme 'Building back better: COVID-19 response and recovery; Meeting the needs, Realizing the rights and addressing the socio-economic impacts on persons with disabilities', the 14th session of the Conference of States Parties to the CRPD will be held from 15 to 17 June 2021. The COSP will gather the international community to explore how to make COVID-19 response and recovery inclusive ensuring the rights of persons with disabilities.

COVID-19 pandemic has highlighted the significant discrimination that the 1.5 billion people living with disabilities around the world still face and the need for all post-pandemic recovery plans to be disability-inclusive to leave no one behind and achieve the Sustainable Development Goals by 2030. Furthermore, the European Union's Union of Equality: Strategy for the Rights of Persons with Disabilities 2021-2030 stresses the need to strengthen disability inclusion in its external action to comply with article 32 of the CRPD.

In this context, the European project Bridging the Gap, launched in 2017 as a flagship initiative of the EU on the inclusion of persons with disabilities in international cooperation, comes to an end achieving results that can be replicated in future





initiatives for inclusion. The side event "Beyond Bridging the Gap: from inclusive policies to community inclusion" proposes a dialogue on the contribution of Bridging the Gap and its consortium to the translation of inclusive policies to "real-life impacts" aiming at supporting the independent living of persons with disabilities in low- and middle-income countries. The dialogue will be based on the results obtained both at global and national levels after four years of work.

Different project's stakeholders, from the United Nations and the European Union to organizations of persons with disabilities and final beneficiaries from the five partner countries of the project (Burkina Faso, Ecuador, Ethiopia, Paraguay and Sudan), will gather around a virtual table to share their views and testimonies on the impact of the inclusive policies promoted by Bridging the Gap, and on ways to capitalize upon the experience and ensure its sustainability.

Introduced by institutional representatives of the project consortium, the main panel will present real-life impacts of Bridging the Gap on the improvement of independent living and community inclusion of persons with disabilities in each partner country. Thus, five persons with disabilities, representing a diversity of disabilities, gender, age, ethnicity, etc., will present how the joint work between governments, international cooperation agencies and organizations of persons with disabilities carried out in the framework of Bridging the Gap has improved their daily lives.

This multi-stakeholder event is sponsored by EDF and supported by the European Union, Austria, Spain, the International Disability and Development Consortium, OHCHR, FIIAPP, ADA, AECID, and AICS as co-sponsors.

The event will last 75 minutes (date and time slot TBC) and will be held in Arabic, English, French, and Spanish. Interpretation in international sign and CART in English, French, and Spanish will be arranged for.

In sum, the event will:

- 1. Highlight the project's contribution to the independent living of persons with disabilities in low and middle-income countries in line with the CRPD and the 2030 Agenda.
- 2. Share personal stories of final beneficiaries of the project on how the project has contributed to improving their independent living and inclusion in their communities.
- 3. Discuss how Bridging the Gap's experience can serve as a reference for future development initiatives of the European external action according to the new European Disability Strategy.
- 4. Raise awareness on the efforts of the EU and its Member States to support disability-inclusive development.
- 5. Identify opportunities for the consolidation of BtG's results.
